## **I. Introduction**

### **Public Relations Activities in support of the Environmental Impact Assessment (EIA) of the National Disposal Facility**

Herewith we present the Stakeholder Engagement Plan in support of the EIA process and the successful realization of the National Disposal Facility (NDF). All activities are based on previous experience with State Enterprise Radioactive Waste (SE RAW) in terms of corporate communication and communication with regard to a previous EIA process, as well as on the accumulated knowledge about SE RAW's structure and functions and its relations with important stakeholders.

The intensive communication and the proactive approach towards stakeholder engagement are of great importance for SE RAW that is responsible for environmental protection activities, health and safety issues. Therefore, a number of activities tailored for each specific key stakeholder are considered necessary in order to ensure public support of the construction of the National Disposal Facility (e.g. Easter children's contest, lectures for teachers and pupils at the Informational Center, discussion meetings with retirees, and bird photo exhibition in cooperation with the Bulgarian Society for Protection of Birds).

The team of MI Media Group is assisting SERAW with developing and applying such activities in order to increase public awareness about the EIA that has been prepared; international commitments of Bulgaria with regard to the construction of the NDF; the character and the schedule of the project and the safety measures, and about the environmental and social responsibility commitments that SE RAW has.

This EIA is required as part of the overall licensing process of the facility: issue of the Construction Permits by the Ministry of Regional Development and Public Works (MRDPW) and the Bulgarian Nuclear Regulatory Agency (BNRA).

Within this process, the EIA Report will be made available for the Public in accordance with the Bulgarian legislation and EBRD's Environmental and Social Policy.

During the EIA Process for the NDF the public may review the document(s), request clarifications and express comments to SERAW as investor, to the licensing authorities and to the team of experts that has developed the EIA Report. SERAW is to respond satisfactorily to these clarifications and comments, taking into account all the recommendations for changes (if any), as well as the proposed other possible ways for implementing or operating the NDF, resulting from the public discussion(s).

A successful management of the Public Disclosure Process is a fundamental step prior to commencing NDF construction, which is subject of a Construction Permit and requires careful management to ensure that all processes are being observed, that the public is fully aware from an early stage, has an opportunity to be fully briefed on the investment proposal and be heard in the implementation of the NDF.

## **II. Project Description, Location and Areas Subject to Impact**

According to Resolution No. 683 of the Council of Ministers dated July 25<sup>th</sup>, 2005, the State Enterprise Radioactive Waste (SERAW) is required to construct the National Disposal Facility (NDF)

for short-lived low and intermediate level radioactive waste (termed Category 2a radioactive waste under Bulgarian regulations). These wastes will primarily arise from the former operation and decommissioning of Units 1-4 of the Kozloduy Nuclear Power Plant (KNPP), but will also include operational wastes from Units 5 and 6 of KNPP and other nuclear power stations (if realized), as well as waste from other nuclear applications (research reactors, hospitals, industrial sites, etc.) in Bulgaria.

The NDF will be located close to KNPP site, in the North-western part of Bulgaria, in the restricted area of KNPP, 3.5 km to the south of the town of Kozloduy and 4 km to the south of the midstream of the River Danube and consequently the boundary of Romania.

In line with the Convention on Environmental Impact Assessment in Transboundary Context and the Bulgarian Environmental Protection Act, the implementation of such a facility is subject to an Environmental Impact Assessment (EIA).

Following a 1<sup>st</sup> EIA process, the Ministry of Environment and Waters (MEW) issued a Decision approving the implementation of the NDF in October 2011. After the MEW Decision was objected by an individual, it was cancelled by the Supreme Administrative Court in November 2013. As a result, the EIA Process for the NDF must be resumed starting from Scope and Content of EIA Report.

Based on the experience of the first EIA report for the National Disposal Facility for Low and Intermediate Radioactive Waste, and based on information provided by the Bulgarian Ministry of Environment and Waters, the communities that would be most sensitive to the implementation of the NDF project would be the ones inhabiting Kozloduy municipality, the municipalities of Mizia, Oryahovo, Valchedram, Hayredin, Borovan, Krivodol, Lom, Boytchinovtsi and Byala Slatina and the village of Harlets (refer to [Attachment 1](#)), together with the Romanian municipality of the town of Bechet, unless otherwise determined by the competent Romanian authorities. The communication activities aim at convincing the communities that the implementation and the operation of NDF is to their benefit, as well as to demonstrate that SE RAW is a socially responsible organization, fully capable to manage the implementation thanks to its expertise.

## **V. Consultation**

### **1. Materials and location of materials:**

- **Monthly Bulletin** dedicated to the realization of the NDF project – information about the Bulgarian project, expert positions and interviews, international experience, best practices in the field, etc. The Bulletin will be distributed to the following recipients: Kozloduy Municipality; Members of the Kozloduy Municipal Council; Kozloduy Community Center; Informational Center of SE RAW in Kozloduy; Office Protocol of SE RAW in KNPP; Mayor of the town of Mizia, Members of the Mizia Municipal Council; Mayors of the municipalities of Oryahovo, Valchedram, Hayredin, Lom, Boytchinovtsi, Krivodol, Borovan, Byala Slatina and the village of Harlets. The Bulletin will be available during the whole legally determined EIA process until the end of the project.
- **Leaflets** – two types of leaflets are prepared. One is dedicated to the general activities of SE RAW and is designed for general public; another one is dedicated to the NDF project, designed for general public. The issued leaflets will be distributed to the following recipients: Kozloduy Municipality; Members of the Kozloduy Municipal Council; Kozloduy Community Center; Informational Center of SE RAW in Kozloduy; Office Protocol of SE RAW in KNPP; Mayor of the town of Mizia; Members of the Mizia Municipal Council; Mayors of the municipalities of Oryahovo, Valchedram, Hayredin, Borovan, Krivodol, Lom, Boytchinovtsi, Byala Slatina and the village of Harlets. The Leaflets will be available also in Romanian for the purposes of the public hearings. The communication with the Romanian authorities is not in the Consultant's scope of activities. If the Romanian authorities require the distribution of printed materials in Romanian, the Consultant shall provide them, if informed in a timely manner.
- **Posters** – posters, informing about meetings, events, discussions and other initiatives, organized by SE RAW, will be put in the Municipality buildings, on boards, in the Informational Center of SE RAW in Kozloduy, in the Office Protocol of SE RAW in KNPP, public places in the villages of the municipalities. Posters will be available prior to each event.
- **Press releases** about key events connected to public discussions and important activities of SE RAW in general and in connection to the NDF project will be issued on occasion. The press releases will be provided to national, regional and local media.
- In order to inform the Romanian public, some of the **information materials** will be published also **in Romanian language** (leaflets, presentations established by SERAW for public meetings) and press releases will be sent also to Romanian media. The printed materials will be provided in Bechet, Romania, as a foreseen location for public hearing, if no other location is additionally indicated. The EIA Report will be submitted to the competent Romanian authorities. If media interest is expressed in terms of questions, requests for interviews, etc. they will be timely met with the appropriate information and assistance.

### **2. Public meetings planned**

**An overall program will be kept up-to-date on the SERAW website with the dates and times of the stakeholder meetings. The program will be prepared and updated together by the Consultant and the SE RAW.**

- **Public hearings with local communities** are planned for the town of Kozloduy, the town of Mizia, the municipalities of Oryahovo, Valchedram, Hayredin, Byala Slatina, Borovan, Krivodol, Lom, Boytchinovtsi and the village of Harlets and in Romania. Dates and places of the meetings will be announced more than one month in advance through local authorities (Mayors, secretariats), through printed materials and through local media (KOZLODUY DNES weekly, Kozloduy-bg.info, and Vizh TV channel), as well as through the website of SERAW – <http://dprao.bg>. The announcements will specifically underline that all stakeholders are invited to take active part in the discussions and state their opinion so the Investor would take into consideration all stakeholders' concerns. The public meeting will be conducted in venues and hours, which facilitate the participation of all stakeholders.

- **All questions and comments** made during the public meetings are going to be taken down and addressed personally during the meeting, if possible. Questions that cannot be addressed during the meeting are to be collected and submitted to competent specialists of SE RAW to provide a response. Answers to the questions are to be provided in the Informational Center of SE RAW in Kozloduy within two weeks. The Investor Statement will summarise stakeholder concerns and provide responses. All questions might be addressed in written form to the e-mail address of the Informational Center of SE RAW and to [info@dprao.bg](mailto:info@dprao.bg) and [infocentar@dprao.bg](mailto:infocentar@dprao.bg) – the mail is going to be published in the leaflets provided by the enterprise, and it is already available on the website of the company.

- **All changes proposed by the local communities** and approved by the management of SE RAW complying with the national legislation will be made public in the Monthly Bulletin and in the Investor Statement.

- **Public hearing** in Romania will be organized in the settlement defined by the Romanian authorities on the dates officially agreed and included in the program. A Romanian interpreter with good knowledge of the language and experience in the topic will be secured in order to facilitate the communication. Information materials in Romanian language (leaflets, presentations established by SERAW for public meetings, stand-alone banners with basic information) will be available in the venue of the public hearings.

### **3. Press conferences for the national and local media on NDF activities related to the Environmental Impact Assessment**

Press conferences for the national and local media will be organized. The exact dates of the press conferences will be defined throughout the process.

## **VI. On-going information**

During the whole period prior to the Public Hearing of the EIA report and after that event, public information concerning the NDF project will be provided. All important information concerning the EIA report, the NDF project and the activities of SE RAW will be published on the website of the enterprise, following the legally envisaged time frame. Information will be provided also to <http://www.kozloduy-bg.info/>. Press releases will be issued to national, local and regional media and also published on the website of SERAW.

The local newspaper KOZLODUY DNES will open a column with Q&A regarding the NDF Project. Most frequently asked questions will be answered by experts from the SE RAW and third parties – environmental, nuclear, medical and other specialists.

## **VII. Grievance mechanism**

The grievance mechanism is depicted in details on the website of SE RAW: all suggestions, complaints and objections concerning the NDF project should be addressed to SE RAW in written form to the following e-mails: [Infocentar@dprao.bg](mailto:Infocentar@dprao.bg) or [info@dprao.bg](mailto:info@dprao.bg). They may be personally presented in written form in the Informational Center of SE RAW in Kozloduy and/or in the Office Protocol of SE RAW. Grievance Forms in Bulgarian, English and Romanian will be provided for those who want to submit a question, comment or complain ([Attachment 4](#)). The Grievance Forms will be available on SERAW's website, as well as in the SERAW Informational Center and SERAW Headquarters.

All incoming written suggestions, complaints and objections should be transferred to the competent experts of SE RAW. Answers and statements should be given within 2 weeks' time. They should be provided via e-mail to the recipient or in written form in the Informational Center of SE RAW in Kozloduy or in the Office Protocol of the enterprise after being approved by the management of SE RAW.
